


Meeting started with the recitation from the Holy Quran. The Grievances of the firm were heard & discussed. Following decisions were taken;





The Firm provided the required documents .i.e Satisfactory Performance Certificate , therefore committee unanimously decided to accept the Grievance of the firm Hence declared Responsive for Stage- 01 (Firm's Evaluation) .
