Interested bidders may get the bidding documents and specifications as per schedule mentioned above from the Office of the Medical superintendent Children Hospital Faisalabad, On submission of written application on letter head and a copy of CNIC along with payment of non-refundable price of Rs. 1000/- (One Thousand Rupees only) for each bidding document.
3. Single Stage, Two Envelop bidding procedure shall be applied. The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters. Financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.
4. Either technical or financial (or Both) found missing in bid, the offer shall automatically consider cancelled.
5. Bid security for all the quoted items should be submitted in form of CDR/Bank Guarantee. If the value of CDR/Bank Guarantee is less than the value of 2% quoted prices of items then the complete bid will be rejected.
6. All bids should be submitted in tape or ring binding. All documents should contain an index and accurate page marking, attached in sequence as indicated for evaluation in the bidding document and signatures & stamp of authorized person are mandatory on every page of technical proposal & financial proposal.
7. The bidder must submit required fresh batch sample (Qty: 06) for tender serial No.1 & 2 of quoted items along with their technical proposal, and fresh samples Qty. 01 for the tenders serial No.4,5 & 6 of the quoted items along with their technical proposals.
8. All participating bidders are requested to quote prices inclusive all applicable Govt. Taxes & Duties. The Conditional offer (Without inclusive taxes) will be rejected.
